Kindly refer to the subject cited above. In this regard, it is intimated that the results of students appearing for the Diploma courses regular & reappear include Pharmacy Examinations for the HSBTE May/June 2026 Examinations of all the semesters have been declared by the Board today, i.e., **07.07.2026**, and are available on the link of the HSBTE ICOP Portal <https://hsbtehry.in/login> (for login at the Institute level). The students can check the result of the HSBTE May/June 2026 Examinations of all the semesters at [http://103.234.185.158/show\\_my\\_result](http://103.234.185.158/show_my_result), by entering the Username as Student Roll No. and captcha as displayed.

In cases where a student does not fulfil the eligibility condition(s), the Board shall be within its right to cancel the result so declared. For example, a student appearing as reappear student in subject(s) in which the student has never appeared as **a regular student**. If any such case is found, the concerned Institute must inform the Board for further necessary action, and the Provisional Certificate of such a student **must not be issued**.

The Provisional certificate (This will be available online) may be issued by the Institute to the eligible students whose results of all semesters/years are clear. **The Institute must also ensure that the rechecking/re-evaluation in any subject of the candidate has not been applied for by the student/uploaded by the Institute on the PCA Application of the Board.**

Furthermore, students who are not satisfied with their declared result of any subject(s) can apply for the rechecking, and also for a photocopy of the evaluated answer sheet up to **15.07.2026** till **05:00 PM** on plain paper to their respective Institutes. All the data regarding re-evaluation/photocopy should be uploaded by the Institutes up to **16.07.2026** on the PCA ICOP Portal <https://hsbtehry.in/login>.

**IMPORTANT NOTICE**

1. While preparing the result, due care has been exercised by the Board. However, inadvertent errors cannot be ruled out, and the Board reserves the right to rectify any such error at a later stage.
2. This result is subject to the fulfilment of all eligibility conditions and may be altered or modified due to corrections, rechecking, or other processes.
3. If a student fails to meet the eligibility conditions, the Board reserves the right to cancel the declared result. For instance, this includes cases where a student appears as a

(a) Fees for re-evaluation of the evaluated answer book: **Rs. 650/- per subject,**

(b) Fees for re-evaluation/photocopy of evaluated answer book after re-evaluation: **Rs. 1000/- per subject.**
